# Midwest Clogging Connection, LLC

## Policies & Terms

### **REGISTRATION**

Registration begins approximately two weeks prior to the next session. Dancers will turn in a registration form to save their spot in the class. Currently registered dancers will have priority.

Completed registration forms and full payment must be received **prior to** the start of each session period.

Registration may be done in person, by mail, or over the phone with a credit card. A completed form is required for each session. Dancers will not be registered until payment has been received. We cannot hold a spot without payment.

Class advancements are subject to approval of the instructor. Classes will run based on enrollment.

All enrolled participants must read and comply with all policies and procedures.

All participants entering class areas must have a signed WCGC waiver and registration card.

### **PAYMENTS**

Tuition is based on individual session periods and due prior to the first class of each session, or according to individual payment plans approved by Midwest Clogging Connection, LLC.

Payments can be made by cash, check, Visa, MasterCard, or Discover. Please make all checks payable to Midwest Clogging Connection LLC (MCC).

All returned checks will receive a \$35 NSF Fee.

All fees are non-refundable. This includes all session fees, annual WCGC registration fee, special event fees, uniform fees and NSF fees.

### **MEMBERSHIP FEE**

All classes at WCGC charge a non-refundable annual registration fee.

Members of the Walworth County Cloggers will pay the clogger rate of \$20.00 per dancer due at time of registration and is capped at \$40.00 per family. (Dancers enrolled in other programs through WCGC must pay WCGC rates.)

### **DISCOUNTS**

There are no make-ups or credits given for absences.

If applicable, when paying in full for a complete session, a \$5.00 sibling or a \$10% clogging mom discount will be applied. For those joining after the session has begun, these discounts are not applicable.

All dancers must pay in full at time of registration.

### **CLASS CANCELLATION**

We reserve the right to cancel classes if minimum enrollment is not met. We will do our best to find another class to place dancers. We also reserve the right to dismiss any dancer for behavioral problems.

Cancellations that result from bad weather will be announced on Channel 12 and placed on the Midwest Clogging Connection website: [www.walworthcountycloggers.com](http://www.walworthcountycloggers.com) Individual phone calls to dancers will not be made due to weather.

### **ATTENDANCE POLICY**

Sessions will be 9-10 weeks. Each class builds upon the skills and material taught the previous week. A short review time is incorporated into class (reviewing the material taught the prior week) however, attending class is important. We build in "OFF" weeks to our sessions to give dancers a chance to take a break from their busy schedules.

### **MAKE-UP POLICY**

No make-ups for absences.

It is very important for you to attend all scheduled classes, as absences may cause you to miss learning a new skill, or mastering a current skill.

### **PERSONAL RESPONSIBILITIES**

No long pants which may interfere with the bottom of the clogging shoe.

No gum. No gum! NO GUM!

No food, or drinks in the studio. Water bottles must be kept outside the studio door.

Bags and other personal items must be stored in the locker room, observation area (by the gym) or may be brought into the studio. If brought into the studio all cell phones must be turned off and bags must not contain any items that may spill onto the studio floor. **Personal items cannot be left in the hallways or on the floor anywhere in the facility!**
